NOTICE OF ASSISTANCE GRANT AWARD
DEPARTMENT OF CULTURAL AFFAIRS –
DCA COMMUNITY WIRELESS MODERNIZATION**

**April 2, 2026
Findings and Conclusions:**

1. The New Mexico Legislature appropriated \$70,000,000 from the general fund to the Connect New Mexico Fund to the Office of Broadband Access and Expansion (OBAE) to establish and implement grant programs set forth in the 2021 General Appropriation Act at Section 17(B)(1) of Chapter 140 of Laws 2021.
2. The expenditure deadline for the funding source is June 30, 2027.
3. The delay inherent in a merit-based program would delay meaningful mitigation of an existing threat to the health, physical security, economic security, cyber security and educational development of New Mexicans.
4. In accordance with the appropriation, and the Assistance Grant rules found at §1.12.21.10 NMAC, OBAE established the Community Connect Grant Program.
5. Through Community Connect grants, OBAE may award financial assistance grants for projects that target communities with poor levels of connectivity and digital inclusion to provide them with sustainable, place-based solutions that meet community needs.
6. On December 29, 2025, the Department of Cultural Affairs submitted an application to establish 213 new access points for Public Wi-Fi networks across 12 public museums and historic sites by June 30, 2027. The Department of Cultural Affairs will provide maintenance and operation of the Public Wi-Fi networks for a minimum of three (3) years after project completion.
7. The Application was submitted with the support from the New Mexico Historic Sites Executive Director, the Department of Cultural Affairs Deputy Cabinet Secretary, and the Department of Cultural Affairs Chief Information Officer.
8. OBAE determined that the Department of Cultural Affairs is the only entity that can satisfy the program requirements in a timely, correct, and cost-effective manner.
