**Agreement No. SEN-26-012 | Amendment No. 1**

THIS AMENDMENT to SEN-26-012 is made and entered into by and between the **Office of Broadband Access and Expansion (“OBAE”)**, a state agency that is administratively attached to the Department of Information Technology and is located at 715 Alta Vista Street, Santa Fe, New Mexico, 87502, and **RediNet**, a multi-governmental joint powers authority, located at 714 Calle Don Diego, Española, New Mexico, 87532, each individually, “Party,” and collectively, “Parties.”

WHEREAS, the Parties initially executed Intergovernmental Agreement Number SEN-26-012 on February 10, 2026; and

WHEREAS, the Parties wish to clarify the purpose of SEN-26-012 in an Amendment.

The purpose of this Amendment is to clarify the purpose of the Intergovernmental Agreement between OBAE and RediNet.

IT IS MUTUALLY AGREED BETWEEN THE PARTIES THAT THE FOLLOWING PROVISIONS OF THE ABOVE-REFERENCED GRANT AGREEMENT ARE AMENDED AS FOLLOWS:

1. **SCOPE OF AGREEMENT.** The OBAE and RediNet shall provide the services set forth in the Scope of Work, which is attached as **Exhibit A** and is incorporated by reference, unless amended or terminated pursuant to this Agreement. **The purposes of this Agreement are to provide to the JPA member jurisdictions (1) connectivity to education, library, government, and healthcare facilities and (2) emergency connections.**

**All other articles and deliverables of the original agreement remain the same.**


