## Internet Service Map Challenge Ends May 18, 2024!

Successful challenges will make challenged locations available for BEAD-funded infrastructure. Increasing Tribal participation in the BEAD Challenge process will assist states and NTIA in having accurate information in order to ensure that this critical funding reaches intended areas. If Tribal Governments do not challenge the **enforceable commitments** on their land, then locations may be marked as “served” (and ineligible for BEAD) even though the commitment does not include a legally binding agreement or Tribal Government Resolution.

## Highlighted Story: Darrah Blackwater Discussing Spectrum Rights

Darrah Blackwater was the guest speaker at the May 8th TWG meeting. She is an attorney and the owner of Blackwater Consulting LLC. Darrah is a proud citizen of the Navajo Nation, from Farmington, New Mexico. With a law degree from University of Arizona Law School and a lifetime of experience, She is using her background and skills to help tribes, companies, and organizations achieve common goals of connectivity, collaboration, and cultivating mutually beneficial relationships.

Darrah informed us about the concept of spectrum sovereignty, Indigenous rights to air waves, and the buildout requirements of the FCC's Rural Tribal Priority Window spectrum licenses. Her presentation informed us on spectrum rights, including what spectrum is, how it's regulated, and how it may fit into an Indigenous worldview.

## **State Digital Equity Capacity Grant Program NOFO Update**

NTIA recently [announced the availability and individual state allocations of \\$811 million in funding](#) to states, territories, and native entities. The [State Digital Equity Capacity Grant Program](#) (SDECG) allows States and territories to apply for funding to begin implementation of their Digital Equity Plans approved under the [State Digital Equity Planning Grant Program](#). The overall purpose of the SDECG Program is to create the conditions where individuals and

communities have the information technology capacity that is needed for full participation in the society and economy of the United States.

NTIA [held a webinar on April 2, 2024](#) to cover the SDECG Program's [Notice of Funding Opportunity](#) and answer live audience questions. The recording and presentation are available on the [BroadbandUSA website](#).

Native Entities (Indian Tribes, Alaska Native Entities, and Native Hawaiian Organizations): The application window will open September 25, 2024 and close on February 7, 2025.

### ***Broadband Deployments in State DOT Rights-of-Way*** **Webinar May 21, 2:00pm-4:30pm, ET**

The American Association of State Highway and Transportation Officials (AASHTO), Federal Highways Administration (FHWA), and NTIA will jointly host a webinar on *Broadband Deployments in State DOT Rights-of-Way*. The event will cover NTIA's Internet For All programs (with a specific introduction to BEAD) and conceptual permitting timelines; provide a FHWA Explanation of Broadband Rule and Fair Market Value (FMV) Provisions; discuss Section 106 and state historic preservation reviews of broadband deployments in DOT Rights-of-Way; and share lessons learned on coordinating broadband projects with state transportation planning. 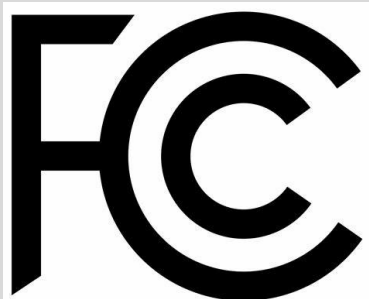

**National Broadband Map Challenge Due Dates You Can Still Challenge the Maps!**

## All MAP CHALLENGES must be submitted by May 18, 2024.

An effective manner to achieve meaningful broadband access for those who need it most, including the unserved and underserved in New Mexico. It is critically important to correct any data that may be inaccurate indicating internet coverage.

- Identify any remaining locations that are missing or misidentified, or availability data which you believe is inaccurate, you may submit a challenge to help improve the data.

### Affordable Connectivity Program (ACP) Reimbursement and Wind Down

- **May 2024** will be the last month for which providers will be able to seek reimbursement for the Affordable Connectivity Program (ACP) benefits.
- Providers are not required to pass through any benefits to ACP households after April 2024.
- Providers can choose whether to pass on and claim the partial reimbursement for May service.

### FCC Seeks Comment on Adding a Missing and Endangered Persons Event Code to the Emergency Alert System

- The Commission released a [Notice of Proposed Rulemaking \(NPRM\)](#) seeking comment on its proposal to adopt a new Emergency Alert System (EAS) event code for Missing and Endangered Persons (MEP).
- The deadlines to submit comments and reply comments for the NPRM are May 20, 2024 and June 17, 2024, respectively.

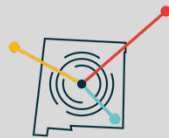

## Connect New Mexico Tribal Broadband Resource Library

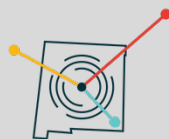
