AMENDED\* NOTICE OF ASSISTANCE GRANT AWARD**

**OHKAY OWINGEH – OFFICE OF THE GOVERNOR –

**Findings and Conclusions:**

1. The New Mexico legislature appropriated \$25,000,000 from the general fund to the Connect New Mexico Fund to the Office of Broadband Access and Expansion (OBAE) to establish and implement a grant program for broadband infrastructure public school projects, as set forth in the 2021 General Appropriation Act at Section 17(B)(1) of Chapter 140 of Laws 2021.
2. The expenditure deadline for the funding source is June 30, 2025.
3. The delay inherent in a merit-based program would delay meaningful mitigation of the existing threat to the educational development of students in New Mexico.
4. In accordance with the appropriation, and the Assistance Grant rules found at § 1.12.21.10 NMAC, OBAE established the Student Connect Grant Program.
5. Through Student Connect grants, OBAE may award financial assistance grants for projects that will connect unserved and underserved public school students within rural communities.
6. On October 29, 2024, Ohkay Owingeh – Office of the Governor submitted an application to connect 187 unserved and underserved student households within Ohkay Owingeh Community School by June 30, 2025. Connected student households will receive broadband connectivity at no cost for three (3) calendar years.
7. The Application was submitted with the support of Ohkay Owingeh Community School.
8. OBAE determined that Ohkay Owingeh – Office of the Governor is the only entity who can satisfy the program requirements in a timely, correct, and cost-effective manner.

3. OBAE will monitor Awardee to ensure the award is used for authorized purposes, in compliance with State of New Mexico statutes, regulations, and the terms and conditions of the award included in the Agreement, to ensure that the award performance goals are achieved.
